LIMITED WARRANTY

One Year Limited Warranty

Volquartsen Firearms warrants to the original retail purchaser of a new Volquartsen Firearms firearm that such firearm operated by the original retail purchaser under normal use in the continental United States will be free from defects in material and workmanship for a period of one year following the date of the original retail purchase, subject to the requirements and limitations stated below which will be strictly applied.

If you make a claim within the limited warranty period, Volquartsen Firearms agrees to correct the defect by repairing or replacing (with the same or comparable quality model), in our sole discretion, without charge, if the firearm is returned to us prepaid with a copy of the bill of sale. Volquartsen Firearms's liability shall be limited to repairing or replacing the nonperforming or defective firearm as determined in our sole discretion. If we send you a new firearm, we will keep the defective one.

This limited warranty only includes parts and labor and return shipping. Volquartsen Firearms will not provide refunds. Volquartsen Firearms reserves the right to inspect any product before making any adjustment covered by this limited warranty. The terms of this warranty cannot be changed except in writing by an officer of Volquartsen Firearms.

This limited warranty extends only to materials used or workmanship performed by Volquartsen Firearms or its employees in the manufacturing of the firearm, subject to all limitations and exclusions set forth herein.

Limited Warranty Service

In order to process your limited warranty claim in the fastest way possible, a Return Merchandise Authorization Number (RMA#) is <u>REQUIRED</u> to be on the outside of <u>ANY</u> returned package. Packages without the RMA# on the outside of the package may be refused in our sole discretion.

To obtain the RMA#, simply call us at 712-792-4238 (or fill out the form available on our website: https://volquartsen.com) and we will provide you with the RMA# to be used to return the product to us.

WARNING: It is illegal to ship a firearm with ammunition in the firearm or in the same packaging. Firearms and ammunition must be shipped separately.

Shipping Costs Excluded

The original retail purchaser shall be responsible for prepaid freight. We will not accept C.O.D. shipments. If there is a defect within 90 days of the date of purchase by the original retail purchaser of a new Volquartsen Firearms firearm, then Volquartsen Firearms will issue a prepaid return tag to the original retail purchaser. For all other returns, the sender is responsible for all shipping charges. If you discover a defect or have a warranty claim, you must first obtain the RMA#, as described above.

Exclusions

This limited warranty extends only to the original retail purchaser of a new firearm and does not give any rights to any other person. This limited warranty does not cover damage to your firearm from normal wear and tear, deterioration due to use or exposure, such as tipping, scratching, fading, negligence, abuse, corrosion, failure to provide proper maintenance, damaged

display guns, gun barrels damaged by an obstructed bore, hand loaded, reloaded or proper ammunition or guns damaged in return shipment due to improper packaging and handling.

This limited warranty does not cover damage by addition or alteration of the product, accidental damage or loss, abuse, failure to provide reasonable and necessary maintenance. Damage that is determined to be of this nature will be repaired at the customer's expense. This limited warranty covers the firearm as originally sold by Volquartsen Firearms, but does not extend to firearms altered or rebuilt after their original purchase, or firearms used other than for their intended legal purpose. This limited warranty does not apply to scopes or accessories attached to the firearm when purchased. Accuracy is not included in this limited warranty. This limited warranty does not apply to barrels.

If Volquartsen Firearms, after receipt of the firearm, determines that the state of defects in material and/or workmanship were the result of any of the above exclusions, or as though not covered by the warranty set forth above, Volquartsen Firearms shall notify such owner to that effect and then give an estimated cost of repair. In such cases repair return shipping and insurance coverages and any other charges shall be paid by such customer.

Normal Use; No Repairs or Alterations

This limited warranty covers only defects in original components which arise from normal use and does not apply if the product has been subjected to negligence, accident, abuse, misuse, neglect or overload or has been repaired or altered without the prior written consent of Volquartsen Firearms. Normal wear items will not be replaced due to wear. Volquartsen Firearms assumes no responsibility for product malfunction or for physical injury or property damage resulting in whole or in part from criminal or negligent use of the firearm, improper or careless handling, unauthorized modification, use of defective or improper hand loaded, reloaded or remanufactured ammunition or customer abuse, neglect or misuse. This limited warranty shall be null and void if any work has been performed on the firearm by anyone other than Volquartsen Firearms. Damage due to use of high velocity high pressure reloaded or other nonstandard ammunition, or any unauthorized repair, modification, misuse, abuse or alteration of the product is not covered and shall also null and void this limited warranty.

All Volquartsen Firearms parts and accessories continue to be sold in "AS IS" with no expressed or implied warranty. Volquartsen Firearms expressly disclaims any liability for incidental or consequential damages or injury which may result from the improper use or installation of any parts or accessories sold or manufactured by Volquartsen Firearms.
